About research

This research is carried out jointly by the University of Turku School of Economics and the FICAN West, the responsible leader of the research is Anni Paalumäki and the research is funded by The Finnish Work Environment Fund. The data controller of the study is the University of Turku, which is responsible for the legality of the processing of personal data in connection with the study and answers questions about data protection and information related to data protection legislation.

In the study, interview material is collected from the participants in the mentoring program and their close work community, and in addition, survey material from the wider network of the FICAN West network.

In the interviews, recordings of the interviews and interview notes are collected as research material. By signing up to be interviewed, you give your consent to the collection and storage of research data as described here. The survey material is collected using the webpropol survey.

All the material we collect is treated confidentially and in accordance with good research practice. The personal data collected in the study will only be processed by the project's researchers and research assistants. The collected material is anonymized and the identities of the interviewees are erased from the results and research reports.
