

- March 2005, at the Fifth Ministerial Conference on Environment and Development in Asia and the Pacific, Seoul, Republic of Korea

- 
- The Conference endorsed Green Growth as a policy on common path for achieving environmental sustainable economic growth by 52 member states of the United Nations for Economic and Social Commission of Asia and the Pacific (UNESCAP)

- Ministerial Declaration on Environment and Development in Asia and the Pacific, 2005, Regional Implementation Plan for Sustainable Development in Asia and the Pacific 2006-2010 and the Seoul Initiative on Environmentally Sustainable Economic Growth (Green Growth)

Green Growth Perspective in Asia and Pacific... (1)



2006: Seoul Initiative on Green Growth: Achieving Green Growth in Asia and the Pacific Region by Promoting Effective Environmental Policies. Toward the goal SIGG were set three targets:

1. **Improving Eco-efficiency for Environmental Sustainability**
2. **Enhancing Environmental Performance**
3. **Promoting the Environment as an Opportunity for Economic Growth and Development**


Green Growth: Cambodia Contexts



Cambodia Millennium Development Goals:

1. Significant improvements in poverty rates in urban and more accessibility rural areas
2. Expansion of primary education to more children
3. Signification reduction in mortality rates for both infants and under-five year olds
4. Improved immunization against major childhood diseases
5. Improved breastfeeding rates
6. Reduction of gender disparity in most areas especially in primary education, adult literacy, and wage employment in agriculture and industry
7. Noteworthy reduction of communicable diseases, especially HIV/AIDS
8. Ensuring environmental sustainability
9. Improved urban access to safe water and rural access to improved sanitation

From the Ministerial meeting result in 2005, Korea

2009: Via the agreement between MOE and UNESCAP, Cambodia was selected as a pilot project country on Green Growth.


And 2009, Inter-Ministerial Green Growth Working Group were formulated

Toward Green Growth Implementing, from 2010-2013 Cambodia were issues several policies and approaches named GG Road Map, GG Policy and Strategic Plan on GG 2013-2030

Working mechanism: Established GG Council with member from all line Ministries and Provincial Governor with Chaired by Ministry of Environment






